**Sub:- Implementation of Juvenile Justice Act and Rules -  
Monthly Inspection of Children's Home and Observation  
Home - Regarding.**

....

I am to invite your attention to the following. The 1<sup>st</sup> Additional District Judges in most of the districts in Kerala have reported numerous problems requiring immediate action in the observation Homes in the districts noticed by them during their monthly visit.

The 1st Additional District Judges of Manjeri, Kalpetta, Palakkad, Kottayam, Ernakulam, Kozhikode and Pathanamthitta have pointed out the following problems which require immediate action.

1. Observation Home and Children's Home at Thavannur, near Kuttippuram, District - Manjeri.
  - i). The water purifier in the Home is not working properly.
  - ii). Service of a Security/Night Watchman is highly necessary.
  - iii). The building needs to be repaired urgently or an alternate accommodation is to be provided.

- iv). Presently no boundary wall exists and a boundary wall is a necessity for the Institution.
- v). Water supply needs to be made effective and regular.
- vi). Provide a vehicle to the Institution.
- Vii). Service of a psychologist is to be arranged for inmates and regular medical check ups and counseling to be provided.

2. Observation Home and Children's Home, Puthuvayal,district - Kalpetta.

- i). The rented building which houses the Observation Home and Children's Home lacks adequate infrastructure.
- ii). Since September, 2014 the Institution lacks a regular Superintendent.

3. Juvenile Home cum Children's Home at Muttikulangara, district - Palakkad.

- i). Lack of security - It has been reported that 3 Juveniles escaped from the Home in 2015. One of them returned Home. The other two were booked later.
- ii). The Juvenile cum Children's Home lacks sufficient place for playing.
- iii). Lack of proper Infrastructure.

4. Observation Home and the Children's Home, Kottayam district - Kottayam.

- i). The premises needs cleaning up.
- ii). The condition of dining hall and toilets are unhygienic.

5. Government Observation Home and Children's Home at Kakkanad, district - Ernakulam.
- i). At present the full charge of the Institution including the charge of the Superintendent is given to a person on the Administrative side. The absence of a full time Superintendent is not conducive for the proper functioning of the Institution. A full time Superintendent needs to be appointed.
6. Observation Home and Children's Home at Vellimadukunnu, district - Kozhikode.
- i). The post of Superintendent in the Observation Home for boys is not filled.
- ii). Posts of Music Teacher, Tailoring Instructor and Ayah are lying vacant in the Home for girls.
- iii). The inmates have complained about the poor quality of food being served in the Home for Boys.
- iv). A young inmate, a boy, complained of harassment and beating by senior inmates.
- v). The visits of the counsellor attached to District Child Protection Unit is irregular.
- vi). The training programme for the Caretakers have to be streamlined and implemented.
7. Observation Home and Children's Home at Paravanadukka, district - Kasaragod.
- i). Steps to send a juvenile by name Suresh to his native place at Villupuram, Tamil Nadu is pending. The matter has been reported to KELSA. Assistance from KELSA has to be ensured in the matter.

8. Observation Home - cum - Children's Home at Vayalathala district - Pathanamthitta.

The Home doesn't have electrical connection.

In the light of the above reports I am directed to request you to take necessary corrective and remedial measures with regard to the issues mentioned above and submit an Action Taken Report before this Court within a period of 2 months.

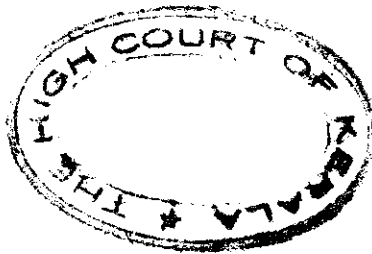

As directed in the Official Memorandum cited, I have conducted the monthly inspection of the Observation Home and Children's Home at Thavanur near Kuttippuram on 27<sup>th</sup> day of July, 2015.

2. I may submit as follows:-

On my inspection, as part of monthly visit, I have verified the records of the Children's Home and realized that there are 19 inmates available in the Children's Home.

3. On verification of the records of the Children's Home it is seen that one inmate named Santhosh is seen released 14-7-2015, another inmate named Muhammedali transferred to Areacode Orphanage on 22-7-2015. Two inmates named Fahad and Fazil are seen admitted on 16-7-2015 and they were released on 19-7-2015. Faizal, Anu, Anandu and Nayanesh are seen admitted in pursuance of the order of Child

Welfare Committee, Malappuram, on 8-7-2015. One Ramshad is seen released on 28-6-2015. Mohammed Said is seen released on 29-6-2015. Viṣhnu and Vinesh have got admitted at a hōstel at Thirunavaya.

4. The hall used for Observation Home now converted and used as study hall for the inmates. I have given specific instruction to Mr. Subair, the officer in charge, to remove the articles found in a room which are heavy in weight as they are readily accessible to the inmates and there is possibility of misusing the same by the inmates.

5. In these circumstances, I may also submit that the most priority may kindly be given to my previous reports and this report and necessary direction may kindly be given to the authorities concerned in this regard.

I may sum up this report with the following;

Suggestions

1. Water purifier is not working properly.
2. A security/night watchman is highly necessary.
3. Repair the building or provide alternate accommodation.
4. Boundary wall is a must.
5. Provide effective regular water supply.
6. Provide a vehicle.
7. Provide regular medical check up and service of psychologist.

Report of inspection of Observation Home cum Children's Home at Puthurvayal, Kalpetta, Wayand District conducted on 01-09-2015 as per the direction of the Hon'ble High Court of Kerala Vide O.M.No.D1(B)21147/2010/D3 dated 28-01-2014.

\* \* \*

I have conducted inspection of the Observation Home cum Children's Home at Puthurvayal, Kalpetta for the month of August, 2015 on 01-09-2015. The Home has been functioning in a rented building at Puthurvayal since May, 2014. The new building at Kaniyambetta is under construction.

As the Home is functioning in a rented building, the inmates experience inconvenience due to lack of infrastructure. Even today, a regular Superintendent is not posted in the Home. From September, 2014 onwards, the post of Superintendent remains vacant. The Child Welfare Inspector attached to the District Social Justice Office is holding the additional charge of the Superintendent of the Home.

Now, there are 21 children in the Children's Home. An inmate by name Vishnu C., has passed the plus two examination. He got admission to Computer Science Engineering Diploma course in the Government Polytechnic at Thrikkaripur, Kasargode District. He has filed an application before the Taluk Legal Services Committee, Vythiri requesting to shift his earmarked seat for orphan child from Thrikkaripur Polytechnic to Meppady Polytechnic. It was forwarded to the Kerala State Commission for Protection of Child Rights. The said Commission took up the matter. Accordingly, the Director of Technical Education passed necessary orders and thereby shifted the said earmarked seat to the Government Polytechnic, Meppadi. Necessary orders was also issued by the Director of Technical Education in this regard.

I have visited its Dormitory, Kitchen, Dining room and its premises. I noted that its over all functioning is not satisfactory. I gave necessary direction for its improvement and the general hygienic condition.

As per the directions contained in the official memorandum of the Hon'ble High Court under reference cited, I conducted monthly visit of the Juvenile Home cum Childrens Home at Muttikulangara, Palakkad on 29.06.2015. At present, there are 12 children in the Juvenile Home. It is informed that 3 juveniles absconded and only one of them was returned. It is also informed that they are taking active steps to find out the absconded juveniles. There is no separate Security Guard in the Juvenile Home.

The Caretaker therein stated that since it was fasting days in connection with Ramzan, the children woke up in the early morning and while they were preparing food, the children absconded. One of the children is about to attain the age of 18 years and they were planning to remove him to a Vocational Training Centre. On my last visits, I remember that he has good manners and he has no criminal antecedents. There is nothing particular further to be reported.

I inspected the Observation Home and the Children's Home, Kottayam on 31.08.2015 at about 3.30 P.M.

2. Two juveniles-in-conflict with law are found detained in the Observation Home. 35 children are in the Children's Home.

3. I interacted with the juveniles-in-conflict with law. They raised no serious complaints against the officials.

4. The hygienic conditions of the premises of the Children's Home are not better. The toilets used by the inmates are left unhygienic.

5. Cleanliness has not been maintained in the dining hall attached to the Children's Home. I instructed the Superintendent of the Observation Home to ensure cleanliness on the premises.

**REPORT**

Sub: Implementation of Juvenile Justice Act and Rules – regarding.

1. I may report that I visited the Government Observation Home and Children's Home at Kakkanad on 31.8.2015, at 4 pm and 4.30 pm respectively.

2. There are three juveniles in conflict with law in the Observation Home. At the time of my visit, Sri Haridas who is the Caretaker was present along with the attender Sri Aliyar. The three juveniles were playing carrom in their room at the time of my visit. Their details are as follows:

1. Sri Somanath, aged 17 is from Odisha. He was in the Juvenile home when I visited the place on 29.7.2015. It is stated that his case is nearing completion before the competent court.
2. Sri. Ron, aged 16 is from Varapuzha, Ernakulam District. He is studying in 9<sup>th</sup> class in the Boys High School, Paravoor. His parents and younger brother are living in their native place. It is stated by the Caretaker that he was involved in a case and that is pending trial. His parents are brought him to the Observation Home since he was in the habit of taking ganga with his friends.
3. Sri Toppen Naik, aged 17 from Odisha. It is stated by the Caretaker that there is some doubt with regard to his age

and his case is pending before the First Class Magistrate Court, Muvattupuzha. The offence alleged against him is u/s 379 of IPC with an averment that he committed theft of mobile phones. There in the interaction with him, I found that he could not communicate properly with others and it is for the police to find out his native place in Odisha.

3. I may also report that even though there is a post of Superintendent for the Observation Home, the post is lying vacant and I was informed that person by name Sri. Prakash who is in the administrative side is given full additional charge of this institution. The absence of a full time Superintendent is not conducive to the proper functioning of the institution.

4. Thereafter I visited the Children's Home. As on 29.7.2015 Smt. V. Lekha who is the Superintendent was absent. As I stated in my report dated 30.7.2015, she is a native of Alappuzha and it is doubtful whether she is regular in her presence in the institution. It was already observed in the previous report that the Children's Home at Kakkanad requires more effective supervision and monitoring so as to ensure the benefit of the same to the girls in a more productive manner.

5. At the time of my visit two clerks by name Smt. Devi and Smt. Sheeja were present. Caretaker Smt. Shiji and Care provider Smt. Smitha along with Sri Sarasu who was the cook were present. It was stated that there are 85 inmates in the institution and 41 persons were present at the time of



my visit. Even though there is a post of Probationary Officer in the institution, she was absent at the time of my visit. The absence of the Superintendent and the Probationary Officer would definitely affect the institution in a negative manner. Effective follow up action is necessary in this regard.

5. None of the inmates of these institutions made any complaint with regard to their food, accommodation or other arrangements.

With reference to the above, I may submit that I visited the Observation Homes and Children' Homes situated at Vellimadukunnu in Kozhikode district on the afternoon of 30<sup>th</sup> July-2015. The inspection report with respect to each home, and the report regarding compliance of the undertaking given by the Director, Department of Social Justice are as follows:

**I. OBSERVATION HOME FOR GIRLS**

I reached this home at 03.00pm. Caretaker Smt.Naseeda was present there. She would say that the post of the superintendent of this home is lying vacant and one person named Sasikala, who was the superintendent of Short-stay Home, is in charge of this home

now. At present, there are no inmates in this home. This home was found kept tidy. I completed the inspection here by 03.05pm. and left to the other home.

## II. OBSERVATION HOME FOR BOYS

I reached this home at 03.10pm. Caretakers Sri.Abdul Rahiman and Sri.Kunhammad were present there. Caretaker Sri.Abdul Basheer was on leave. The post of the superintendent is lying vacant. Smt.Sasikala, Superintendent of the Short-stay Home, was in charge. On the date of inspection, she was not present there. There are six inmates in this home now out of whom, one is a Bangladeshi. All the inmates have got cases in Juvenile Justice Board. I had interacted with the inmates named Mohammed Rajeb, Manoj, etc;. They would say that long adjournments are being given in their cases before the Juvenile Justice Board. I verified the records and found that there is merit in their allegation. The case of Rahulraj was on 22-7-2015 and the same was adjourned to 11-9-2015. It was submitted that evidence in this case was over. They have no complaints regarding the food, shelter, or amenities given now. They were found happy. So I completed the inspection here and left to the children' home for boys.

## III. CHILDREN' HOME FOR BOYS

I visited this home at 03.30pm. The Superintendent was not present there. But the Deputy Superintendent Ashokan and some other staffs were present. I verified the attendance register of the employees in this home. As per the register, there were twenty five staff members including the superintendent out of whom, two posts are lying vacant. There are sixty five inmates in this home at present. Out of them, eleven inmates are not attending school. One inmate named Arjun is admitted in the Medical College Hospital, Kozhikode. I interacted with some of the inmates to ascertain whether they have any complaints. From the inquiry, it was revealed that they have got complaints regarding the quality of food especially served for breakfast. They were saying that iddali(ഇഡലി)

and uppimavu(ഉപ്പിമാവു) served in the morning were not properly cooked. One of the inmates-a young boy-complained that senior inmates are beating and harassing him. This complaint was brought to the notice of the deputy superintendent. Thereafter I visited the kitchen. The kitchen was found kept clean. I was told that yoga classes are being arranged in this home. I completed the inspection here at 04.10pm. and proceeded to the other home.

#### **IV. CHILDREN' HOME FOR GIRLS**

I reached this home at 04.15pm. The Superintendent named Pushpa was gone to the Treasury. There were twenty four staff members as per the attendance register maintained in this home. The posts of music teacher, tailoring instructor, and ayah were found lying vacant. Altogether, there were eighty nine inmates in this home out of whom, one is on leave and another is admitted at the Mental Health Centre, Kozhikode. I interacted with some of the inmates. They have no complaints of any sort. The entire premises of this home is kept clean. I visited the kitchen and found it maintained neatly. I had also visited the bathroom, latrine etc; and found those kept clean. By 04.45pm, I completed my inspection.

#### **REPORT REGARDING COMPLIANCE OF THE UNDERTAKING GIVEN BY THE DIRECTOR, DEPARTMENT OF SOCIAL JUSTICE**

I was told that doctors from IMHANS attached to Medical College Hospital, Kozhikode are visiting the institution. The deputy superintendent who was present would say that they are getting the service of the counselor attached to District Child Protection Unit, but he would add that the counselor is not visiting regularly. I was also told that the institution is getting the service of Legal-cum-Probation Officer, District Child Protection Unit. I was also told that track child register and individual care plan with respect to the inmates are being prepared and they are awaiting a technician from the department to upload data in the computer. On a perusal of the minutes, it is seen that a

'Meeting of the Inmates'(Baalasabha) was held on 03-7-2015 and the next meeting is scheduled to be held on 02-8-2015. I could understand that vehicles are being hired to take the inmates to the school and back. The deputy superintendent would say that no training is imparted under the aegis of Tata Institute of Social Science, but they have obtained training under the leadership of the Chairman of Child Welfare Committee, Thrissur. I was told by the deputy superintendent who was present in the institution that he had no knowledge regarding the steps taken to give training to the caretakers under the aegis of Tata Institute of Social Science.

Sir,

In obedience to the direction of Hon'ble High Court of Kerala, I have inspected the observation home as well as children's home which are situated in Paravanadukka on 26.08.2015 at about 2.30 pm along with office staff and submit this report for kind perusal.

I may state that there were 11 children in the children's home and out of which 7 children were gone to school. There was only one juvenile in conflict with law in the observation home. Master Muhammad Faisal who was released on bail on the date of inspection. The children who were presented in the observation home did not make any complaint except non availability of fan, non functioning of Television and a few electrical switches. I drew the attention of the superintendent of the Juvenile home to the aforesaid matter, he pointed out that the electrical executive Engineer, PWD, Kozhikode has prepared an estimate dated 13.05.2015 for ₹. 4,21,000/- for electrical maintenance of the building. He further stated that immediate installation of electrical switches will be done so that electricution if any can be avoided.

I may submit that I decide to intimate the above facts to the PWD Electrical

Division, Kasaragod to take necessary action to avoid electricution.

I submit that the meeting of the management committee held on 05.06.2015 and 09.07.2015 discussed the various measures to be taken for the welfare of the inmates and also decided to include the officials of the PWD building section in the management committee.

I may state that the work of the new building is in progress.

It is submitted that an order bearing No. 505/2015 dated 25.01.2015 by the Child Welfare Committee to transfer the juvenile namely Suresh aged 12 years, who was the witness in STC 21/14 on the file of C.J.M Court, Kasaragod to his native place at Villupuram, Tamil Nadu. However the Child Welfare Committee, Tamil Nadu does not seem to display enthusiasm to take back the child to his native place. I have decided to implement my predecessors decision to intimate KELSA on the matter. It is seen that letter dated 09.07.2015 addressed to Kerala State Legal Service Authority requesting the help and aid for the above matter, so far as no reply has received. Hence I decided to address the Kerala State Legal Service Authority once again.

It is seen from the register that Dr. Narayana Naik, Medical consultant/pediatrician of District Hospital, Kasaragod is used to visit the institution on every Friday of each week and take care of the health condition of the children of the institution. The children did not make any complaint regarding the health condition.

I visited the kitchen and found that it was well maintained and clean. Food being provided is free from complaints.

It is learned that ₹. 2,000/- each for the inmates is allowed for "ONAKODI" by the Government of Kerala due to the onam festival.

The above facts are respectfully submitted.

I interacted with them. They wished Onam greetings.

4. The Juvenile Court building has not obtained electricity connection yet. The Juvenile Home and premises has been spruced up for Onam. It is being kept clean and tidy. Functioning of the Observation Home cum Children's Home is going smoothly. The inmates and authorities of the Observation Home are doing well.

I returned by 04.45pm.
