As per the minutes read as 2nd paper above, Empowered Committee had decided to construct District Early Intervention Centres in all the 14 Districts in places provided by the Health Department and also approved the plan & estimate prepared by Habitat Technology. As per the minutes read as 3rd paper above, the SID Implementation & Monitoring Committee has decided to consider Government approved agencies for constructing DEICs, in addition to PWD, since the work has to be completed within one year. As per the minutes read as 4th paper above, it was decided to provide funds to the agencies on submission of projects and had approved the project report and the estimate submitted by the following agencies.
