**ORDER**

Government have approved a framework for Government-Civil Society Partnership in Government welfare schemes and formulated an NGO Accreditation manual for utilizing the service of NGO's in Governmental Activities especially in welfare sector vide G.O. read as 1<sup>st</sup> paper above. An Accreditation Council with the Minister for Social Justice Department as chairman was also constituted for accreditation of NGO's for the Social Justice Department. The Accreditation Council has been modified by including Home Secretary and State Police Chief as members in the Accreditation Council as per the Government Order read as 2<sup>nd</sup> paper above. As per the NGO Accreditation manual for Social Justice Department, the following non-official members will have to be nominated to the Accreditation Council.

- a. Two representatives of Industry Group noted for their philanthropic commitment.
- b. Persons who have expertise at national level in accreditation, in management (preferable a faculty from IIM), law, social sciences and media.(not more than 5)

The Director, Social Justice Department vide letter read as 3<sup>rd</sup> paper above has submitted two panels for consideration as members in the Accreditation Council.
