ORDER

As per the Government Order read as 3rd paper above, sanction was accorded for the release of an amount of Rs.125,00,000/- to Kerala State Women's Development Corporation under the head of account 2235-02-103-89 (P) for meeting the recurring/administration expenses of REACH Finishing School for women. Now, the Managing Director, Kerala State Women's Development Corporation, as per his letter read above, has informed that the amount of Rs.125 lakhs for which the release is sought has been utilised to the tune of Rs.79 lakhs as on 28.02.2015 by using Corporation's own fund and the remaining fund shall be utilized by 30th September 2015.

(2) Government have examined the matter in detail and are pleased to accord revised sanction for the release of an amount of Rs.79,00,000/- (Rupees Seventy Nine lakh only) to Kerala State Women's Development Corporation under the head of account 2235-02-103-89(P) for meeting the recurring/administration expenses of REACH Finishing School for women subject to the condition that the release shall be made only as per the guidelines in Government Orders read as 2nd and 3rd paper above.
