ORDER

As per the Government Order read as 1<sup>st</sup> paper above, administrative sanction was accorded for the Suraksha @ School project of Kerala State Women's Development Corporation for an amount of Rs.50 lakh for the financial year 2014-15 under the Flagship Programme on Gender Awareness. Now, the Managing Director, Kerala State Women's Development Corporation, as per his letter read as 2<sup>nd</sup> paper above, has requested to release the fund of Rs.50 lakh for the implementation of the Suraksha @ School project.

(2) Government have examined the matter in detail and are pleased to accord sanction for the release of an amount of Rs.15,00,000/- (Rupees Fifteen lakh only) under the head of account 2235-02-103-90 (02) (P) to Kerala State Women's Development Corporation for the implementation of the Suraksha @ School project for the financial year 2014-15 subject to the following terms and conditions.

- The amount shall not be parked in Banks/Financial Institutions other than Treasuries. The instructions stipulated in Circular No. 75/2009/Fin dated 29.08.2009 shall be followed.
- The instructions in Circular No. 84/2008/Fin dated 09.12.2008 shall be scrupulously followed.
- The Corporation shall furnish duly authenticated detailed component wise statement of expenditure, Utilisation Certificate in form no. 44 KFC and Economy Certificate while forwarding the proposal for further release.
- The amount shall be utilized during the current financial year itself and for the purpose for which the same is sanctioned.
