CIRCULAR

Sub: GAD-Observance of 'Constitution Day' on 26th November 2022 in all Educational Institutions and Government Departments - Instructions issued - Regarding.

Ref: D.O.No.701/2/2/2022-CA.V Dated 7.11.2022 from the Cabinet Secretary, Government of India

Government of India has notified 26 November as 'Constitution Day' to commemorate the adoption of the Constitution of India and to pay tribute to the invaluable contribution of Babasaheb Dr.Bhimrao Ambedkar and other founding fathers of the Constitution. Every year as a part of the Celebrations a number of activities aimed at highlighting and reiterating the values and principles enshrined in the Constitution are organised. In connection with the celebrations, Government of India has decided to read out 'Preamble to the Constitution' (as it exists today) in all Government offices, Autonomous bodies, Organisations, Local Self Government Institutions State Legal Services Authority/District Legal Services Authority etc throughout the country on 26th November 2022 and to organise competitive activities like Talks/Webinars by eminent citizens on Fundamental Duties etc.

In the above circumstances, all District Collectors, Heads of Departments and Chief Executives of Public Sector Undertakings/Autonomous Bodies are directed to arrange programmes for observing 'Constitution Day' on 26th November 2022 (Saturday) by reading out 'Preamble' to the Constitution at 11:00 a.m in all Government offices. All educational institutions are also directed to read out the 'Preamble' to the Constitution and the fundamental duties as enshrined in Article 51A of the constitution during the assembly session on 25th November, in case 26th November is observed as a holiday. It is further directed to conduct the Activities such as webinars, debates, speeches, essays and quiz competitions on the constitution of India in connection with the observance of Constitution Day. Universities may have special talks on the constitution.
